Before that, he spent nine years at Janus Henderson Investors, launching their global fixed income platform in London in 2010 and serving as a portfolio manager across various global macro and credit strategies. Earlier in his career, Ryan worked at BlueMountain Capital Management in London and held positions at Morgan Stanley and Lehman Brothers in New York.
